8. Match and Permit Committee Report

Washouts in finals

- We had washouts in the finals of all three competitions last season
- Thanks to the clubs who had to host multiple times as a result

Team entries

- Team entries for this season 511 teams 65 grades
 - o 138 teams in Ladies down 4 teams
 - o 125 teams in Mixed up 2 teams
 - o 248 teams in Men's down 14 teams and 2 grades

Team withdrawals

- There have been two team withdrawals:
 - Mixed A Grade Sydenham
 - o Men's A Grade Delahey

Court works - Keilor Park

 Due to court works, all matches due to be played at Keilor Park will instead be played at Bulla Village until further notice.

Additional registrations and emergencies

- Emergencies cannot play more than three matches in total, regardless of which grades they are played in (not three matches in one grade). It is the responsibility of the Club to keep track of how many matches emergencies have played. Please ensure that additional registrations are submitted before players play a fourth match, otherwise teams will lose games.
- The number of additional registrations is down so far, but we are still receiving some that are due to players being left off team entry sheets. Clubs a reminded that once teams have been graded, the additional registration and emergency rules apply, which means players cannot strengthen teams. This means that if, for example, the best or second best player in a team is left off the team entry form, and the team is graded without them, they will be refused additional registration as they will strengthen the team after grading. It is therefore very important that you check your team entries to ensure all players are included.
- Emergency players:
 - Where it is clear an emergency has strengthened a team, teams will be penalised with loss of games.
 - o If a team is told not to play a particular emergency player again, and the team then plays a different emergency who also strengthens the team, a second warning will not be given.

- Loss of games will be automatically imposed. This carries over between seasons. Loss of games will still occur when the team was told not to play the emergency player in a previous season.
- Where an emergency player is told not to play again in a particular grade, and plays in a higher grade and again strengthens the team, a second warning will not always be given.
 Coordinators will look at how much higher the grade was and how much the player strengthened the team.

Spring 2019 team fees

- Fees and Payments must be received by the Treasurer no later than 7.00 pm on Tuesday, 17 September 2019.
- Late payment will result in loss of match points.

Scoring system

- The Match and Permit Committee has discussed a couple of options to change the scoring system to address the number of defaults
- One option is to record a standard score for walkovers (e.g. 18 games to 0 games, or 12 games to 0 games).
- Another option is to award two points per set and additional points for a win (like NSJTA matches)
- An options paper will be developed and circulated to clubs for feedback to see if there is any interest from clubs in these changes.

Finals

- It was suggested at the AGM that the higher finishing team hosts finals.
- The Match and Permit Committee has discussed this, and there are a number of issues that would need to be decided in order to make this work.
- Firstly, consideration would need to be given to whether finals have two courts. If that is the case, recent season show approximately 3 Ladies, 3 Mixed and 10 Mens semi finals would need to be relocated each season.
- Another concern is who would resolve disputes, particularly if there is a difference of opinion about whether courts are playable in wet conditions.
- The Committee will discuss these matters further and report back to clubs at a future meeting.

9. General Business

 Application for exempetion to use multi-lined courts has been submitted by PEGS. Kay Ehrenberg spoke on behalf of PEGS asking clubs for their support.

Ballot held to approve PEGS multi-lines exemption.
