#### 8. Match and Permit Committee Report

#### Women's competition

- West Brunswick have submitted a proposal to change the name of the Ladies Competition to the Women's competition.
- As it requires a change to both the Constitution and the By-laws it will be circulated to clubs and voted on at the Annual General meeting.

#### **Avondale Heights match relocations**

Avondale Heights are shortly getting their lights replaced and courts resurfaced. They will
contact clubs to relocate matches once the works commence.

#### Heat rule

- Robert received a number of phone calls before a Wednesday night where the temperature was predicted to be 37 degrees.
- The NSNTA does not have a specific heat rule but follows the Tennis Australia extreme weather
  policy which is very detailed and has a heat limit of 38 degrees for adult competitions.

# Approved balls

- Please ensure that you check the list of approved balls each season.
- The Committee has confirmed its previous decision that clubs have a grace period of 6 months
  to use up their supply of previously approved balls from the date they are removed from the
  Tennis Australia approved list.
- The following notice has been placed on the NSNTA website: Clubs are given a grace period of 6 months to use up their supply of previously approved balls from the date they are removed from the Tennis Australia approved list. Clubs should email chairman@nsnta.org and advise the NSNTA if they are using this grace period. To view the list of previously approved balls, check the previous season's printed fixture or check with the Chairman of the Match and Permit Committee.

# **Additional registrations**

- Additional registrations for Autumn 2024 close this week (Round 12) as follows:
  - o Ladies Competition Tuesday, 30 April 2024 at 7.00 pm
  - o Mixed Competition Wednesday, 1 May 2024 at 7.00 pm
  - o Men's Competition Thursday, 2 May 2024 at 7.00 pm

No late additional registrations will be accepted.

- The Chairman will respond with confirmation that he has received each additional registration.
  This only means that it has been received, not accepted. Usually we wait for a player to have
  played three matches before accepting an additional registration. We reserve the right to refuse
  an additional registration after Round 13 or Round 14 if a team waits until then for a player to
  play their third match.
- Contact will only be made with the Club if an additional registration has been refused.
- There were 165 additional registrations and 35 deregistrations this season. The majority have been in the Men's competition 85 additional registrations.
- Please ensure your team has enough registered, qualified players for finals. A player must be registered and have played three matches (washouts included) to be eligible to play finals.

#### **Finals**

- Results of Round 14 to be phoned through to Peter Olney by 11.00 p.m. on 9354 9019
- Do not phone through semi final and Grand Final results
- Aim to have finals draw up that night
- Clubs must advise by Monday 13 May 2024 if any courts are unavailable for finals, otherwise we assume courts are available.
- Players must be **registered** and have played three matches to be qualified for finals. Each competition (Ladies, Mixed and Mens) is a separate competition, and qualification for one does not count towards qualification for the other. No exceptions will be made to this rule, so please ensure teams have enough registered, qualified players and don't have to forfeit a final.

#### Team entries for next season

Close 8.00 pm on Friday, 7 June 2024

- Team entries must be sent in <u>Microsoft Excel format</u>. We use a macro to assist with importing player statistics for grading, which will not work if team entries are sent in a different format.
- Player lists will be provided to all clubs after Round 14. Please ensure player names are spelt correctly. You can copy and paste names from the player history lists into the team entry sheet.
- Please only list players that intend to play. Do not blindly copy all names between seasons. Clubs should be a commitment from players that they intend to play again.
- Please ensure an appropriate grade is applied for particularly check on ability of new players and new teams.
- If there is a particular reason you are applying for a grade, such a player has left the team, please write this on the bottom of the team entry sheet so the Committee are aware when grading.
- Please ensure all players are listed. Additional registrations will be refused if strong players are left off the team entry even if the player has played in the team for many seasons.
- Some players on the lists may be marked as "Too Strong". This means they played an emergency this season, but were deemed to be stronger than the other players in the team. We encourage you to register these players if they are going to play next season. If an emergency player has been deemed "Too Strong" this season and then they play as an emergency in the same team next season, the team will be automatically penalised with loss of games.
- If you know the player comes from another club, put that information on the bottom of the sheet
- Do not put in a team with only 4 players in it register the players a team will use in the event of an injury or unavailability
- If there is a new player to your Club, check with the Coordinators or Chairman for previous history
- Please limit the number of special fixture requests as it makes it very difficult for the Committee to complete the draw. If too many clubs submit special requests, they cannot all be accommodated and some clubs will miss out

# Spring 2024 dates

- Mixed Wednesday, 7 August 2024
- Men's Thursday, 8 August 2024
- The Ladies Competition will not play on Cup Day and the Mixed and Mens will not play the week leading up to the AFL Grand Final long weekend.
- The pickup for fixtures will be at the AGM on Monday 29 July 2024.

#### **Team withdrawals**

- Following feedback from clubs, the Management Committee had decided not to proceed with the proposal to remove team withdrawals.
- However, we request clubs confirm player commitments before submitting teams to avoid team withdrawals as much as possible.

# Light testing and policy

- The new NSNTA lighting policy takes effect on 1 July 2025 We previously sent letters to most clubs likely to be affected by the new lighting policy which takes effect on 1 July 2025.
- If your club has taken action to improve its lighting, please let us know so the lights can be retested.
- If your club has received a letter, please ensure it starts taking action now, so it is ready by 1 July 2025.
